
ENACTED by the National Assembly of the Federal Republic of Nigeria as follows:

1. There is established the University Teaching Hospital Lafia, for the purpose of training of medical and other health professionals, providing tertiary health care services, conducting health related researches, and other related matters. Establishment of the Hospital and the Management Board.
2. The composition, functions and powers of the Board established under subclause (2) of clause 2 shall be as provided for in the University Teaching Hospitals (Reconstitution of Boards, etc.) Act, Cap. U15, LFN 2004. Composition, functions, etc., of Board.
3. This Bill may be cited as the University Teaching Hospital, Lafia (Establishment) Bill, 2021. Short title.

Explanatory Memorandum

This Bill seeks to establish the University Teaching Hospital, Lafia and a management Board for the hospital, for the purpose of providing such facilities for the training of medical and other health professionals, providing tertiary health care services, conducting health related researches, and other related matters.
