# A BILL FOR AN ACT TO AMEND THE LEGAL EDUCATION (CONSOLIDATION, ETC.) ACT BY ESTABLISHING THE CAMPUSES FOR THE NIGERIAN LAW SCHOOL; AND FOR RELATED MATTERS, (SB.820)

} Commencement

ENACTED by the National Assembly of the Federal Republic of Nigeria as follows-

The Legal Education (consolidation Etc.) Act (in this Bill referred to as "the Principal Act") is 1. amended as set out in this Bill.

Amendment of the Principal Act

Section 1 of the principal Act is amended by inserting new subsections (3) and (4) as follows: 2,

Amendment of Section 1 of the Principal Act

- (3) There shall be established, a minimum of 2 Campuses in each of the six (6) Geo-political zones, as specified in the Schedule to this Bill.
- (4) Subject to the provision of subsection (3) of this section, creation of additional Campuses of the Nigerian Law School shall be approved by the National Assembly through legislation whenever the need arises.
- This Bill may be cited as the Legal Education (Consolidation Etc.) Act (Amendment) Bill, 2022. 3.
